Subject: Regarding issuing approval certificate to schools as entailed to Sub Rule (4), Rule 11 of the Right of Children to Free & Compulsory Education Rules, 2011 for the purpose of section 18 of the Right of Children to Free & Compulsory Education Act, 2009.

Respected Sir/Madam,

As per your application dated 16/06/2025 for the purpose of school inspection, I, Bhaskar Patil, Education Officer (Primary), Zilla Parishad, Ahiliya nagar, am providing temporary approval to **Sri Sri Ravishankar Vidya Mandir**, Taluka Sangamner Khurd Dist. Ahiliya nagar for Standard I to Standard VIII for a duration of three (3) years from 01/04/2025 to 31/03/2028.

The aforementioned approval has been given on the following terms and conditions:

1. Approval duration shall not be increased and there shall not be any obligation to provide approval or affiliation post standard VIII under any circumstances.

2. The school shall adhere to provisions of the Right of Children to Free & Compulsory Education Act, 2009 (Annexure 1) and the Right of Children to Free & Compulsory Education Rules, 2011 (Annexure 2).
3. The school shall provide admission to children from weaker sections and deprived sections in the first standard up to 25% capacity of that standard and provide them with free education till completion of primary education. However, it shall be noted that this proportion must be implemented for pre-primary standards, too.
4. The children notified in Paragraph 3 shall receive reimbursement as per section 12 (2) of the school's act. The school shall be provided a separate bank account in order to receive this reimbursement.
5. Society/School shall not recover any capitation fee and shall not force any child or his/her parents or guardians for any type of scrutiny.
6. Any child shall not be denied admission to school due to lack of age proof, religion, caste or race, place of birth or any of the reasons above.
7.
 - (1) None of the children who has been given admission in school shall be retained in the same standard or expelled from school until completion of his primary education.
 - (2) None of the children shall be tortured physically or mentally.
 - (3) None of the children shall be required to pass examination of any board till the completion of primary education.
 - (4) Every child that has completed primary education shall be issued certificate as prescribed under Rule 23.
 - (5) Handicapped/specially disabled students shall be included in the school as per provisions of act.
 - (6) The teachers shall be required to acquire the minimum qualification as prescribed under section 23(1) of the act within 5 years of service.
 - (7) The teachers shall discharge their duties as prescribed under section 24(1) of the act.
8. The school shall implement the curriculum based on the syllabus prescribed by appropriate authority.



9. As prescribed in section 19 of the act, students shall be allotted admission in school based on the available facilities.
10. As prescribed in section 19 of the act, the school shall adhere to the standards and norms.

11. Classes or standards not approved for the school shall not be allowed to be taught in the school premises or elsewhere.
12. The school building or other construction or playground shall be strictly used for education and skill development purpose only.
13. The school is managed by a society registered under Societies Registration Act, 1860 (21 of 1860) or the Bombay Public Trusts Act, 1950.
14. The school shall not be run for the benefit of any group or association of any person or any person or earn any profit.
15. The accounting books shall be audited by Chartered Accountant and appropriate accounting statements shall be prepared as per rules. A copy of every accounting statement shall be sent to District Education Officer every year.
16. The approval code number allotted to your school is **12-018-34-026**.
17. All the reports and information sought by the Education Director/District Education Officer or any instructions or suggestions given by government or local authority in order to continuous fulfilment of terms of approval or eliminate any shortcomings in school's proceedings.
18. If the registration of school's society is due to renewal, it shall be renewed duly.
19. Other terms have been attached herewith as per Annexure 3.



20. If cases like fulfillment about registration with Hon. Charity Commissioner, Office Bearer Change Report, Renewal, Audit, etc. are pending, then required reports shall be submitted and fulfilled and latest copy of Appendix 1 received from Hon. Charity Commissioner shall be preserved in school records carefully.
21. If there are disputes in the society, an administrator shall be appointed for school by the Hon. Charity Commissioner, Ahmednagar or the office bearer mentioned in Appendix 1.
22. It shall be binding on both society as well as government to adhere to decisions, resolutions, circulars, orders and work methods issued by government.
23. It shall be binding on schools approved under 'Self-Financed Schools' basis to adhere to all provisions of the Maharashtra Self-Financed Schools (Establishment and Regulation) Act, 2012 (01 of year 2013).
24. Permission has been granted to start a school having name '**Sri Sri Ravishankar Vidya Mandir**', at Taluka Sangamner Khurd Dist. Ahiliya nagar for English medium school. No change in the medium or location shall be permitted in future. In case if any change in them by school or society, the aforementioned approval shall stand cancel automatically. Further, the school shall be deemed unauthorized with effect from the date of such change.
25. The concerned society shall be responsible to obtain U-DISE Number for the school from competent authority. However, the school shall be responsible to enter information of every student enrolled in the school in the Saral System, keep it up-to-date, link Aadhaar, to submit U-DISE Proforma in the prescribed duration and format to concerned officer, to conduct all the required proceedings under Advanced Educational Maharashtra, etc.
